Why are crime and justice statistics important?

- Accountability, transparency and democracy
- Component of social and economic wellbeing: visibility to an area of social concern
- Evidence in a politicised space
- Performance measurement
- "What works" evaluation support
- Informed decision making for policy designers, operational and support activities, strategic planning, research and community





Relevance of Crime and Justice Statistics for policy making

- Informed decision-making and evidence-based policy
- Key questions: who, what, when and how?
- Relevant for crime prevention, operational planning, design and evaluation of interventions, forecasting, cost benefit analysis
- Alternative sources of information?







The Australian Experience: crime and justice statistics

Crime and Justice Statistical System comprises:

- many data collectors and custodians across the crime and justice sector
- a set of complementary national collections (administrative by-product data, surveys, multi-mode compilation)
- Some shared statistical infrastructure and frameworks
- Adoption of a shared data quality framework
- Statistical initiatives such as principles for data integration, Measures of Australia's Progress, etc.

The Australian Experience: crime and justice statistics

Australian Bureau of Statistics Act 1975, Section 6(1):

- a) To constitute the circula statistical authority to Chevenstration Government and, by arrangements with the Governments of the States, provide statistical services for those Governments:
- b) To collect, compile, analyse and disseminate statistics and related information;
- c) To tank stic ad-ordination and integrations of official bodies in the collection, compilation and disconjunction of statistics and related information, with particular regard to:
 - i. The avoidance of duplication in the collection by official bodies of information for statistical purposes,
 - ii. The attainment of comparability between, and the integration of, statistics Standards of the statistics and

iii. The maximum possible utilisation, for statistical purposes, of information, and Statistical selection of information, available to official bodies;

- d) To formulate, and ensure compliance with, standards for the carrying out by official bodies of operations for statistical purposes; International statistical collaboration and co-ordination
- e) To provide advice and assistance to official bodies in relation to statistics; and
- f) to provide liaison between Australia, on the one hand, and other countries and international organisations, on the other hand, in relation to statistical matters.





The role of NSOs in crime and justice statistical system

- Production of independent, authoritative statistics using administrative and survey methodologies
- Equally important statistical leadership and co-ordination
 - (quality, standards, efficiency)
- Partnership with legal agencies and institutions is essential





The role of NSOs in crime and justice statistical system

- Helping data users understand fragmented data
- Building statistical capability for data custodians and user community

Australian Bureau of Statistics

How to improve crime statistics

- Linkages to key statistical frameworks, crime and justice data important beyond the sector
- Strong engagement with the sector and an aim of building collaborative partnerships
- Coordination across a whole statistical system not simply silo activity controlled by an NSO, justice agencies or alternative providers
- Focus on all dimensions of quality, including coverage, comparability and accessibility
- Greater international collaboration across nations
 - especially to respond to emerging, transnational and complex crimes
 - foster efficiency and comparison opportunities across jurisdictions
- Build statistical literacy and capability in the field, media, etc.
